The Ibrahim Salem collection of paper money the Maghreb countries, Libya and Sudan represents many years of dedication and patience in an effort to collect as comprehensively as possible a complete run of all the types and dates available on the open market together with several of the essays, proofs and specimens as and when they came on the market, albeit very infrequently. The Libya banknotes collection presented in this book is unique by being the only known complete collection of issued notes along with many one of a kind archival material of the unadopted designs.

Libya didn't have its own banknotes up to its independence and establishing of the Kingdom in 1952. During the Italian occupation, the Italian Lira was in used with no special distinguish mark on the banknotes. When the Allies took control on the country, the British military authority issued in 1943 under the title "Military Authority in Tripolitania" the Military Authority Lira, in per with the Italian currency.

Towards the introduction of the Libyan pound in 1952 several proposals were made, all included in this collection. The first proposal is most interesting as it was inspired by the Egyptian series at the time (the Egyptian pound was widely circulated in Libya after WWII), depicting King Farouk in three-quarter bust with sceneries of the country. As such the proposed designs depicting the future King Idris in three-quarter bust and all denominations includes sceneries. As the as the official name of the country and status were not yet determined the English title is "Government of Libya" but in Arabic it is "Emarit Libya" literally means the Principality of Libya. At that time, Idris held the title of Emir, and not King.

Later proposals show resemble to the actual notes released into general circulation.

The Republic era is also well represented in this collection and in a full, including post Ghadaffy era. It includes many of unadopted designs which showing the design processes up to the final chosen design which was used to the actual notes.

Introduction

This book I present to respected readers, collectors, and others is a compilation of my Libyan banknotes collection. Algeria, Tunisia, Mauritania, and Morocco are in a separate book, and Sudan is in a different book. Following that is my collection of Egyptian banknotes to be printed soon.

The primary purpose of issuing this book became necessary after I decided to put all my banknote collections of these countries for sale through respective auctioneers. It is time that this elite collection sees the light and is in the right spot where fellow collectors can enjoy and acquire, if interested, by auction.

Libya is one of the largest countries in North Africa, with an area of 1,760,000 km² and a coastline of 1,770 km on the Mediterranean Sea. The country is one of the wealthiest countries in the world due to its oil, minerals, and agricultural products, as well as its location facing Southern Europe and the limited population of seven million.

Without going back too far in history, just the beginning of the twentieth century, Libya suffered from the Italian occupation that began in 1911 and the French intervention in its affairs, as well as the British occupation in 1943 during WW II. Libya gained its independence on 24 December 1951 and became a kingdom. On 1st September 1969, a coup d'état threw the king, and Libya became a republic under the command of President Muammar Qaddafi until he was overthrown in 2011.

For some decades, I kept chasing the Libyan banknotes from the British Military Authority in Tripolitania, then the United Kingdom of Libya, the Bank of Libya, the Central Bank of Libya, and finally, the Republic of Libya. I acquired not only issued banknotes but also a massive variety of specimens, color trials, composite essays, and die-proofs. This collection has a lot of unadopted designs and archival printer photographs that cannot be found anywhere nowadays.



I had a memory of a few years ago when I wrote about the three prominent figures of Libya: King Idris I, Omar El Mukhtar – Lion of the Desert, and Muammar Qaddafi in my book (Banknotes of Destiny, Fame..Fortune.. Fatality) issued in 2016. These three men are the only ones depicted on Libyan banknotes. Readers will see these three men in different denominations and poses, either in issued notes or unadopted examples.

Readers may realize that I have a duplicate or triplicate in several cases, which are identical. This book is an album archiving my collection that I will remembered with in the future. I hope readers enjoy this book and it will be an excellent addition to your library.

MILITARY AUTHORITY IN TRIPOLITANIA

British Occupation – WW II

Introduction

The lira (Arabic ليره, plural lire, abbreviation MAL), officially known as the Military Authority Lira, was the currency of the British zone of occupation (later Mandate Territory) in Libya between 1943 and 1951, and of the province of Tripolitania until early 1952. It was issued by the Military Authority in Tripolitania and circulated together with the Italian lira at par. This situation reflected that of Italy, where the AM-lira was minted by the United States. The Tripolitanian and the Italian lira were replaced in early 1952 by the Libyan pound at a rate of £L1 = 480 MAL.


Free French troops occupied Murzuk, a chief town of Fezzan, on 16 January 1943, and proceeded to administer Fezzan with a staff stationed in Sabha, forming the Military Territory of Fezzan-Ghadames. French administration was largely exercised through Fezzan notables of the family of Sayf Al Nasr. Disquieting to the tribes in western Fezzan was the administrative attachment of Ghat, and its surrounding area, to French-ruled Algeria. However, when the French military control ceased in 1951, all of Fezzan became part of the Kingdom of Libya.

The title "Government of Libya" and in Arabic "Emarit Libya" was used on the design as the official name of the country was not yet determined. Interestingly, unlike the issued notes, the design includes sceneries, and King Idris was depicted on all denominations.

UNADOPTED PRINTER'S ARCHIVAL PROOFS (1950)



The Emirate of Cyrenaica (Arabic إمارة يرقة) came into existence when Sayyid Idris unilaterally proclaimed Cyrenaica an independent Senussi emirate on 1 March 1949, backed by the United Kingdom. Sayyid Idris proclaimed himself Emir of Cyrenaica at a 'national conference' in Benghazi. The recognition by the UK failed to influence the attitude of the United Nations, and Britain and France were directed to prepare Libya's independence in a resolution passed on 21 November 1949. The independence of the Kingdom of Libya was declared on 24 December 1951, and on 27 December, Emir Idris was enthroned as King Idris I.



Notes from this series carry the date 24 October 1951. This is the date on which the law was passed, authorizing the issue of notes by the Libyan Currency Commission. The notes were actually issued in 1955. The first series of notes circulated for three years, after which it was decided to introduce a new series of notes. It is probable that, after three years, a new order of notes was necessary to replace dwindling reserves. The requirement for new order of notes offered an opportunity to change certain features of the notes. It was now possible to include the details of the new law authorizing the issue of the banknotes, and it was possible to introduce the signatures of two members of the Libyan Currency Comission.







King Idris 1951 - 1969

For the sake of brevity, Libyan colonial money has been omitted. Suffice to say that the emergence of the newly free Libyan state necessitated a new currency to reflect the nation's autonomy. King Idris seems to have started with the contemporary portrait model, later moving on to a more historical approach. As early as 1952 Libyan paper money began to show a portrait of King Idris, as seen on Figure 1.14 This is not surprising; a portrait would have sent the clear message that he was in control of the newly formed Libyan state, effectively demonstrating a clean break with the recent colonial past. This need not be taken as evidence of Idris' autocracy; indeed, given the relative political instability of the time, establishing exactly who was in power may have proved to be a necessity.




